*Customer maintaining less than 20 KW demand*

**Power Rate**

*Customer exceeding 20 KW demand*

Customer Charge .....	\$28.00 per month

Demand Charge: October-June bills.....	\$11.00 per KW
Energy Charge: .....	\$.036 per KWH
Minimum Bill .....	Customer Charge

The billing demand shall be the customer's greatest 15 minute demand incurred during the month the bill is rendered. For billing purposes, monthly peak demand will be adjusted to a 95% power factor. Watertown Municipal Utilities reserves the right to designate the rate class.

If service is at primary voltage, customer will pay all costs incurred in the ownership, operation and maintenance of transformers or other related substation equipment. A 2% discount on demand and energy charges shall be applied to a power rate customer electing service at primary voltage.
